Your Privacy

In the course of communication with Pleasecountme.org we may collect some personal information about you. This Privacy Policy tells you how Pleasecountme.org uses and works to protect your information.

This includes the use of any personal information you have shared with us and its transfer to and storage on our servers.

Information that we collect

We may collect information about you, including:

- Information that you provide to us to become counted ;
- Contact information, including first and last name, phone number, email and mailing address.
- Employment status information and other information you may provide us with.
- Other information we may legally be required to collect from you.

How we use the information

We use the information we collect to:

- Provide you with the information and services you request
- Communicate with you about your transactions and other administrative issues
- Send you information, based on your communications preferences
- Measure and improve our sites and services
- Resolve disputes, address complaints and troubleshoot technical problems
- Analyze site and user behavior and prepare aggregated reports that we can use to then create infographics or other reports that may help to shape public perception
- Comply with applicable laws and regulations

Sharing and Disclosure

We will not share your information with third parties for their marketing purposes without your explicit prior written consent.

To provide our products and services, we may disclose your information to the following parties:

Service Providers. We may share information with service providers under contract who help with our business operations. Our service providers are required to keep the information confidential and use it only for the services they provide to us.

Legal and Other Disclosures. We may disclose information (i) when permitted and/or required by law or under the good-faith belief that such disclosure is necessary under applicable law; (ii) to comply with legal process served on Pleasecountme.org to protect the property or interests of Pleasecountme.org, its members and employees; or (iii) to protect personal safety or the public.

Unsubscribe - Opt-out

At any time, you have the option to opt out of receiving marketing communications from Pleasecountme.org. However, while you are a registered Pleasecountme.org member (you've opted in to be counted) you can not opt out of administrative correspondence (for example, delivery of your profile information at your request through email, or correspondence about your transactions or our policy changes)

It may be necessary to continue to provide you with information and services related to your profile, and we will complete the account closure process at that time. After we close your account, we may retain some information to comply with law, prevent fraud, assist with investigations, resolve disputes, analyze or troubleshoot programs and take actions otherwise permitted by law. If your account or membership is terminated or suspended, we may retain some information to prevent re-registration.
